I refer to the appointment of Richard Tucker, David Osborne and Tony Miskiewicz as voluntary administrators of the Companies on 30 June 2023 ('the Administrators') and Philip Campbell-Wilson and Said Jahani as receivers and managers of the Companies on 4 July 2023 ('the Receivers').

Pursuant to section 439A(5)(b)(i) of the Corporations Act 2001 (Cth) ('the Act'), the convening period applicable to the Companies ends on 28 July 2023, being 20 business days from the date of appointment of the Administrators. Pursuant to section 439A(2) of the Act, the Administrators are required to convene the second meeting of creditors of the Companies within 5 business days before or after the end of the convening period, being by no later than 4 August 2023.

The Administrators are in discussions with the Receivers on various matters relating to the affairs of the Companies. The Administrators have determined that an extension of the convening period is required to enable sufficient time (amongst other things):
