**Notice of Extension of Deadline for Member Substantiation Forms

On 6 May 2022 by Order of the Supreme Court of New South Wales ('the Court') ('the Winding Up Order'), Kate Conneely and I, Scott Langdon, were appointed joint and several liquidators of the Fund. I advise that Kate Conneely subsequently retired as a liquidator of the Fund on 7 February 2024. For the avoidance of doubt, I continue to be appointed as sole liquidator of the Fund ('the Liquidator').

The purpose of this letter is to notify Interested Persons of the extension to the deadline for potential members to complete and return the Member Substantiation Form.

This deadline has been extended from the previously advised 12 August 2024 to **9 September 2024**.

What do you need to do?

The Liquidator requires information from you to consider if you may be a member entitled to participate in a distribution.

Please complete and return the Member Substantiation Form with any available supporting documentation by the new deadline date of 9 September 2024.

If you have already submitted these forms and have not been notified of a request for further information, you do not need to submit your substantiation forms again.

To assist in completing the Member Substantiation Form, please also refer to the FAQ on the KordaMentha website. The Member Substantiation Forms can be returned via email at botanymillfund@kordamentha.com or mail to KordaMentha, GPO Box 964, Brisbane QLD 4000.

Please note, if you do not have any supporting documentation relating to your membership, you are encouraged to still complete and return the enclosed Member Substantiation Form.

Next steps

Once the new deadline response date has passed, the Liquidator will return to the Court to:

- Confirm members have been appropriately classified based on the Rules and evidence provided
- Confirm any evidence provided by the member, or otherwise located by the Liquidator, is sufficient to determine eligibility
- Confirm how a distribution should be calculated and paid to relevant members.

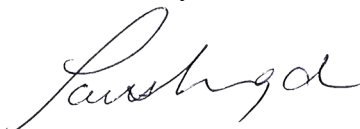
I will report to members again prior to making this application.
