(b) By 4.00pm on 4 March 2015, the eighth defendant upload to the abovementioned website, copies of:

(i) the Claim and Statement of Claim filed on 19 December 2014;



- (ii) the eighth defendant's Application filed on 17 February 2015 for directions under section 96 of the *Trusts Act* 1973 (Qld);
- (iii) this order;
- (iv) the Statement of Facts drawn pursuant to section 96 (1) of the Trusts Act 1973 (Qld); and
