- 1. I make this affidavit from my own personal knowledge of the facts, save where I state to the contrary.
- 2. I or entities controlled by me are investors in 11 Timbercorp managed investment schemes as follows:

- 3. In total I have invested \$239,380 plus a substantial amount in annual rent, maintenance and operating costs.
- 4. I am a Chartered Accountant aged 58. I am a responsible manager to two companies that hold Australian Financial Services Licences to act for managed investment schemes.
- 5. I planned my investments in Timbercorp as part of my overall retirement plan. The deferred payments under the forestry schemes which I anticipate receiving from this year onwards, and the cash flow from the almond and olive schemes form a substantial part of my income expectations over the next 20 years.
- 6. I attended the meeting of members of the Timbercorp forestry schemes held on 31 July 2009 by videolink and voted in favour of the resolution put to the meeting. Now produced and shown to me and marked with the letters **DSB-1** is a copy of the notice of meeting.
- 7. The reasons why I voted in favour of the resolution were that I thought the proposal would result in either a continuation of the schemes if Gunns or TC Growers were the successful bidder or, if a buyer of all the forestry assets were the successful bidder, I would receive a pay out for my trees which would equate to their commercial value, and that there were safeguards in the apportioning of fair value to the trees, namely the involvement of the Timbercorp Growers Group through Owen Lennie in the process and the ultimate sanction of the court.
- 8. From the outset of the administration and subsequent liquidation of the Timbercorp companies I have been mystified why solvent and viable schemes have to continue to be run by an insolvent responsible entity under the control of liquidators who are also liquidators of other Timbercorp companies whose assets are used by the schemes and who are therefore in conflict in their duties to the creditors of those other companies and to the scheme members.

2. Voting and required majority

- (a) Given the need to ensure that all Growers have adequate information on which to make an informed decision in respect of the non binding proposal the Liquidators have retained an independent expert in both Accounting and Forestry to prepare reports for distribution to the Growers.
- (b) It is anticipated that these independent reports will be made available to Growers via the KordaMentha and Timbercorp websites before the scheduled Grower meetings. We have also asked the independent experts to make themselves available to answer questions on their reports at the meetings.
- (c) After having the benefit of reviewing the independent experts reports and hearing their presentations, Growers will be able to vote in the following ways;
 - (i) In person at the Grower Meetings. Growers will receive a voting form at the meetings; or
 - (ii) By appointing a proxy to attend the Growers Meetings and then make a decision on their behalf. The proxy appointment form is attached to this notice and the proxy will receive a voting form at the meetings; or
 - (iii) On-line via the KordaMentha website at <u>www.kordamentha.com</u> or Timbercorp website at <u>www.timbercorp.com.au</u> from 12 noon on Friday 7 August 2009 until 4pm Monday 10 August 2009. You will need your Timbercorp Grower ID in order to vote on-line.
