MINUTES OF FIRST MEETINGS OF CREDITORS Timbercorp Group of Companies as per the enclosed schedule (All Administrators Appointed) ("the Companies")

Held at The Grand Ballroom at The Sofitel Hotel, 25 Collins Street, Melbourne Victoria on 5 May 2009 at 11:00am

Introduction

Mark Korda introduced himself as Chairman and welcomed the creditors to the First Meetings of Creditors of the Timbercorp Group of Companies (All Administrators Appointed) ("the Companies") as per the handout given to all creditors and observers upon entry to the Grand Ballroom (Appendix 1). The Chairman advised that the first meeting of creditors of Timbercorp Securities Ltd (Administrators Appointed) would be held at 2pm that afternoon. He also introduced Leanne Chesser, Mark Mentha and Craig Shepard who are joint Administrators with Mark Korda of various Companies in the Timbercorp Group. He then introduced John Stragalinos, who was the legal advisor for the meetings.

The Chairman advised the meetings had been called pursuant to Section 436E of the Corporations Act, 2001 ("the Act"). The creditors were advised the purpose of the meetings was to determine whether to appoint committees of creditors and, if so, who those committees ought to be comprised of.

The Chairman commented that creditors present would have an opportunity to ask questions of the Administrators, however only creditors of the respective Companies, not observers, would be permitted to ask questions.

Chairman

The Chairman declared the meetings of the Companies open at 11:02am and that pursuant to Regulation 5.6.17(1) of the Corporations Regulations, he would be chairing the meetings.

Time and Place Convenient

The Chairman explained that given the Administrators' appointment on 23 April 2009 and the need to determine a time and venue for the meetings by 24 April 2009, these meetings were convened based on information available to the Administrators at that time. Given the circumstances, the Chairman declared that in his opinion and pursuant to Regulation 5.6.14 of the Corporations Regulations, each of the meetings had been convened at a time and place convenient to the majority of creditors of each company. He then tabled the following documents:

- A copy of the Notice of Meetings of Creditors and Notice of Appointment dated 24 April 2009, sent to all known creditors and posted on both the Timbercorp and KordaMentha websites; and
- A copy of the advertisement of the Notice of Meetings of Creditors which appeared on 27 April 2009 in The Australian newspaper.

Attendance

The Chairman considered the creditors present, both in person and by proxy or power of attorney, and enquired whether all those in attendance had signed either the creditors' or observers' registers. Both registers for each of the Companies are attached to these minutes (Appendix 2). The Chairman stated that given the number of creditors present in person or by proxy, it was impractical to read the attendance registers and to individually admit or reject proxies received.

The Chairman advised that whilst he had received both proofs of debt and appointment of proxies for voting purposes, it should not be taken as an acceptance or rejection of a claim, rather, he reserved the right to re-examine any documents should a poll be demanded.

Voting Procedures

The Chairman discussed the creditors' entitlement to vote, and advised creditors that motions were to be resolved by show of hands unless a poll was demanded. He advised the meeting that should a poll be required he would explain the process.

Quorum

The Chairman advised that pursuant to Regulation 5.6.16(2) of the Corporations Regulations and based on proxies received and persons present at the meetings, a quorum was present for each of the meetings.

Concurrent Meetings

The Chairman recommended that given the Timbercorp group structure, forty (40) meetings of creditors were to be held. The Chairman advised that he intended to hold each of the meetings concurrently. There were no objections.

Prior Involvement of KordaMentha

The Chairman advised KordaMentha had no prior professional relationship with the Companies. Involvement prior to the appointment was solely to prepare for the orderly conduct of the Administrations. He tabled a revised Declaration of Independence, Relevant Relationships and Indemnities, which did not materially differ from that sent to creditors. He advised this would also be loaded on the Timbercorp and KordaMentha websites.

Administrators' Address

The Chairman provided a brief background on the Companies under Administration. This presentation is attached to these minutes (Appendix 3).

Questions and Answers

The Chairman reiterated that only creditors of the Companies were permitted to ask questions.

George Kalil, Axis Financial Advisers

How can the Companies have collected \$2 billion in grower contributions, yet only have \$598 Million in net assets?

The Chairman advised that this does not include the growers' assets, and also advised that the Administrators will conduct an investigation.

George Kalil, Axis Financial Advisers
Is the loan book 7% in arrears, as reported in The Australian Financial Review, or is it higher than this amount?

The Chairman referred this question to Craig Shepard, joint Administrator of Timbercorp Finance Pty Limited (Administrators Appointed) with Mark Korda. Mr Shepard explained that on the date of appointment approximately \$14 Million or 3% of the Loan Book was in arrears, however he noted that this may be understated and investigations would continue to determine the accuracy of this figure. Mr Shepard also commented that a process would be implemented to aggressively assess and recover all arrears.

Tom Collin, Oolloo Farm Management Pty Limited (Mango and Avocado Famers)
When the Administrators suspended operations, what were farm operators expected to do with employees and leased equipment?

The Chairman advised that operations were suspended as farm managers were incurring costs that the Companies could not afford to pay. The Administrators were in the process of applying to court to approve the granting of a lien over crop proceeds in respect of Olives. In addition, he informed that the Administrators' staff were reviewing the projects on a crop by crop basis. He also recommended that for further clarification on farm operations, he speak with Mark Mentha or Andrew Malarkey after the meetings, as both were dealing with the day to day horticultural operations of the Companies.

George Kalil, Axis Financial Advisers
I am interested to know how Select Harvest harvest the almonds, and how the proceeds are distributed to both the grower/investors and Timbercorp?

The Chairman advised that the example provided would be generic as every scheme and project would be different. He outlined that proceeds were paid into a custodial account. Timbercorp Securities Limited (Administrators Appointed) then authorises those proceeds to be paid to the growers and to Timbercorp.

George Kalil, Axis Financial Advisers
Is the custodian the same as the Responsible Entity?

The Chairman outlined that this was not the case, and that in the schemes, a third party was the custodian.

Guiseppe Coronica, Creditor
What type of security is held over the \$478 Million loan book? What incentive is there for investor/growers not to default?

The Chairman explained that the loans in the loan book, some of which extend for up to ten years, are loans to people made in their personal capacities. He outlined that he expected people to pay loans in accordance with their contractual obligations. If this does not occur, legal action would commence. The Chairman also added that the value of the security over the loan book was yet to be determined, and that all loans were required to be paid, irrespective of the performance of the underlying asset.

Mark Sheldon, Financial Advisor
Where do you think you will be able to obtain finance to fund operations going forward?

The Chairman outlined that the Companies currently operate at the secured lenders' discretion. For short term funding the secured lenders would continue to be consulted. For long term funding, he acknowledged the difficulty in the current financial climate of locating purchasers for asset sales.

There were no further questions.

Confirmation of Administrators

The Chairman advised that pursuant to Section 436B of the Act, the creditors may replace the Administrators.

The Chairman advised that as no nominations for alternative administrators were received, the appointment of the Administrators stood.

Committee of Creditors

The Chairman noted that the substantive part of the First Meetings of Creditors was to elect committees of creditors. He then added that pursuant to Section 436F of the Act, the function of a committee of creditors

of a company under administration is to consult with the administrator about matters relating to the administration and also to receive and consider reports from the administrator. Pursuant to Section 436F(2) of the Act, the committee of creditors cannot give directions to the administrator except to require the administrator to report to the committee about matters relating to the administration as and when reasonably required.

The Chairman outlined the requirements of committee members and noted that the committee usually includes a representative of each class of creditors. The Chairman commented how the Committees of the Companies should include representatives of;

- Secured creditors
- **Employees**
- Suppliers/Trade creditors
- Lessors

()

He further stated that section 436G of the Act provides that a person could only be a member of the committee of creditors if the person was:

- A creditor of the company; (a)
- The attorney of such a creditor because of a general power of attorney, or **(b)**
- Authorised in writing by such a creditor to be a member of the committee. (c)

Section 436G(2) of the Act provides that if a member of such a committee is a body corporate, the member may be represented at meetings of the committee by:

- An officer or employee of the member; or (a)
- An individual authorised in writing by the member for the purposes of the subsection. **(b)**

The Chairman announced that creditors of the respective Companies ultimately decide whether or not a committee of creditors is formed and the membership of these committees.

He also noted that membership of a committee of creditors was voluntary.

The Chairman advised that he was of the opinion that there should be a committee of creditors for certain Timbercorp Group Companies. The relevant companies were listed on an overhead.
