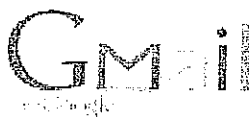

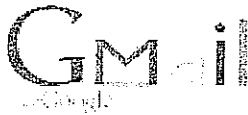

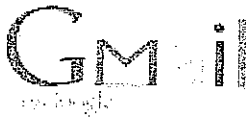
I appreciate you being so vocal and asking the questions. I am a doctor and good at what I do – people trust me to do that job well, I would expect the same of those to whom I entrust my money.
