I found it astounding that I could be legally dispossessed of my trees, especially given that the olive and almond lots still seem to be functioning and the eucalypts trees need for maintenance is minimal once they are established. However, I wonder whether anyone is winning from further objections, other than the administrators and the lawyers(?)

Taking on the banks, especially after the administrators have set up some proposals, seems to risk putting more good money after bad. Can you give me a brief idea of the game plan you are proposing, and will it involve more resources?

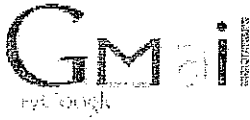
I agree with you that the compensation offered is insufficient.

I write as both a Grower and financial adviser to investors in the above projects.

It would appear that your organisation (including Counsel and Representative Growers) is recommending that Growers should accept the compromise proposal offered by the banks.

In seeking to come to terms with this proposal, I am somewhat lost.

From trying to interpret the detail provided, It appears that approximately \$1.68M in expenses has been incurred to date by funders who have underwritten the Almond Land appeal. It would seem logical that to finance such an appeal that those providing such funding would only do so if they believed there was a strong chance of succeeding?

It would appear that the underwriters may be entitled to receive expenditure to date from the PALTRY \$6M currently on offer to Growers, potentially reducing distributions by around 30%, is this correct?.

Has Counsel representing Growers and Counsel representing the appeal process jointly and collectively formed the view that the offer to Growers should be accepted and that the appeal process should be terminated? On what basis? Didn't the independent consultants suggest that growers entitlements should be potentially some 60-70% of the sale proceeds, what changed?

The above questions, I believe requires an urgent response so that others, like myself, can make an informed decision related to both our interests and those of our clients.

In consideration of the substantial impact the outcome of these matters will have on so many individuals, it would seem that rather than once again racing back into court for the usual "rubber stamp", it would have been far more appropriate to call a meeting of Growers to explain the pros and cons of the above and allow questions to be asked.

One could be forgiven, I believe, for believing that the outcome of all previous proceedings in all the Timbercorp cases was preordained and that such outcomes were agreed by those in the legal and

liquidator professions (who have been the big winners here) who have done nothing more than operated a charade to justify their excessive fees.

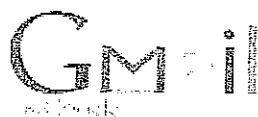
Korda Mentha probably have the most to answer for as in their position as RE they had an obligation to support Growers but never did.
