The Court notes the following matters:

On 14 January 2014, the parties entered into a deed of compromise in relation to this proceeding. A deed of compromise was also entered into in proceeding S CI 2013 01478 (Bella Vista Rights Proceeding). The compromises are conditional on, among other things, court approval of both compromises and an order that absent persons represented by the second and third defendants in each case be bound by the relevant compromise, pursuant to r 16.01(4) of the Supreme Court (General Civil Procedure) Rules 2005 (Vic) (Court

Approval).

- 7. The Approval Application is to be heard together with the application in the Bella Vista Rights Proceeding for court approval under r 16.01(4) of the Rules made.
