

1. Pursuant to s 447A(1) of the *Corporations Act 2001* (Cth) (Act) Pt 5.3A of the Act is to operate in relation to the Second Plaintiffs (Companies) such that notice of the second meeting of creditors convened pursuant to s 439A of the Act (Notice) and the documents required to be sent to creditors pursuant to s 439A(4) of the Act (the Report) may be given by:
 - (a) sending the Notice and an internet link to the Report to the personal electronic addresses of each creditor who has requested that the administrators communicate with them by electronic means;



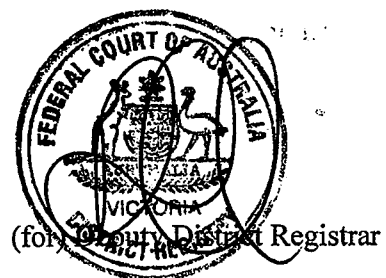

- (b) sending the Notice and an internet link to the Report to the personal electronic addresses of each creditor for whom the First Plaintiff holds such a personal electronic address;
 - (c) sending a one page paper letter and paper copy of the Notice to all remaining creditors who will not receive notification pursuant to Order 1(a) or Order 1(b), along with a statement that the Report is available on the websites of KordaMentha and Timbercorp Limited (Administrators appointed); and
 - (d) causing a notice to be published in a national newspaper (at least 5 business days before the second meetings of creditors) providing:
 - (i) notice of the date, time and location of the second meetings of creditors;
 - (ii) that the Report is available on the websites of KordaMentha and Timbercorp Limited (Administrators appointed); and
 - (iii) details of a telephone hotline number where creditors can request a paper or electronic copy of the Report.
2. Subject to further order pursuant to s 447A of the Act, all future notices, reports and other communications with the creditors of the Companies may be given in the manner contemplated by order 1 above.
3. Liberty be granted to any person who can demonstrate sufficient interest to modify or discharge these orders upon two business days written notice being given to the plaintiff.
4. The costs of this application be costs and expenses in the administrations of the Companies.
