- I, MARK ANTHONY KORDA, of Level 24, 333 Collins Street, Melbourne, in the state of Victoria, Chartered Accountant, SAY ON OATH that:
- I am, with Leanne Kylie Chesser, the liquidator of the First Plaintiff, Timbercorp Securities Limited (in liquidation) (**TSL**).
- 2 Except where I otherwise indicate, I make this affidavit from my own knowledge. Where I depose to matters from information or belief, I believe those matters to be true. I am authorised by Ms Chesser to make this affidavit on her behalf. References in this affidavit to "we", "us", "our" or "ourselves" and "Liquidators" are references to Ms Chesser and me.

M. Torde my

Personal background and experience

I am a chartered accountant and a partner of the firm KordaMentha Pty Ltd (ACN 100 169 391) (KordaMentha). I am a Registered Liquidator and an Official Liquidator of the Court. I am a member of the Insolvency Practitioners Association of Australia and a member of the Institute of Chartered Accountants. Before founding KordaMentha in 2002, I had a 24-year career with the firm Arthur Andersen, during which I held the positions of Director of Corporate Finance, Managing Partner Asia Pacific Corporate Recovery Services Practice and Managing Partner Australia Accounting and Audit Practice. I was also a Member of the Australian Executive Committee and Board of Partners. I have been practising in the area of corporate insolvency and financial reconstructions for 20 years.

Voluntary Administration of Timbercorp Group

On 23 April 2009, we were appointed as voluntary administrators of TSL. Also on 23 April 2009, we, and three other KordaMentha partners, namely Mark Francis Xavier Mentha, Craig Peter Shepard and Clifford Stuart Rocke, were appointed as voluntary administrators of the other Timbercorp group companies (together **Timbercorp Group**). All of the appointments were made by those companies pursuant to section 436A of the *Corporations Act 2001 (Cth)* (the Act).

Liquidation

On 29 June 2009, at the second meeting of the creditors of all the Timbercorp Group and a separate meeting of the creditors of TSL, the creditors resolved to wind up the Timbercorp Group and TSL respectively. From 29 June 2009 we have been the liquidators of TSL.

Table Grape Schemes

TSL is the responsible entity (RE) of the 2004 Timbercorp Table Grape Project (ARSN 108 648 086) (2004 Project) and the 2005 Timbercorp Table Grape Project (ARSN 113 512 236) (2005 Project). TSL is hopelessly insolvent and is unable to continue managing the 2004 Project and the 2005 Project (together, the Table Grape Projects).

The members of the Table Grape Projects are referred to in the governing documents as "Growers" and I adopt that terminology here. The purpose of the Table Grape Projects is the cultivation of table grapes and the harvesting and processing of table grapes for commercial sale.

Purpose of this Application

The purpose of this application is to seek a direction pursuant to section 511 of the Act that we are justified in terminating the Growers' interest in the Table Grape Projects by surrendering or terminating each relevant Grower Licence upon completion of an agreement to sell the property currently licensed to the Growers.

Bella Vista property

- Align Funds Management Limited (previously Orchard Investments Management Limited) (Align) in its capacity as the RE of the Timbercorp Orchard Trust (ARSN 106 557 297) (Receivers and Managers appointed) (TOT) is a property trust. The TOT RE is the registered owner of a property in New South Wales referred to as 'Costa's Crest' and 'Bella Vista' (known collectively as the Bella Vista property). The Table Grape Projects are conducted on the Bella Vista property.
- TOT RE also owns various water rights associated with the Bella Vista property, ramely:
 - (a) water access entitlement of 867 shares held under Water Access Licence 21482 and Works Approval 60CA581917, each granted pursuant to the Water Management Act 2000 (NSW) (the NSW Water Rights); and
 - (b) water access entitlement of 214.0 mega litres per annum held under water share WEE018428 and water access entitlement of 2028.8 mega litres per annum held under water share WEE045487, each granted pursuant to the Water Act 1989 (Vic) (the Victorian Water Rights),

(collectively, the Water Rights).

M. Harle

- A series of lease agreements have been executed by TOT RE and certain Timbercorp Group entities in respect of the Bella Vista property, namely:
 - (a) a lease between TOT RE and Timbercorp Limited (in Liquidation) (Timbercorp) for each of the Table Grape Projects, dated 15 April 2004 and 28 April 2005 respectively, in which TOT RE leases the Bella Vista property to Timbercorp (the Parent Leases).
 - (b) a sub-lease between Timbercorp (as sub-lessor) and TSL (as sub-lessee) for each of the Table Grape Projects dated 15 April 2004 and 28 April 2005 respectively (the Sub-leases).
 - (c) licence agreements between TSL and each Grower in the Table Grape

 Projects (Grower Licence).

I refer to the affidavit of Paul William Kirk sworn on 22 December 2010 and filed in this proceeding (**Kirk Affidavit**). The Parent Leases, Sub Leases and Grower Licence agreements are exhibited to the Kirk Affidavit, marked 'PWK1' - 'PWK6'.

Receivers

On 22 October 2009, Trust Company (Nominees) Limited (ACN 004 154 441) (**Trust Company**) appointed Mr Longley and Mr Kirk (of PricewaterhouseCoopers (**Receivers**) as the joint and several receivers and mangers of the charged assets (including the Bella Vista property and Water Rights) of TOT RE as trustee for the holders of debentures issued by TOT RE. The Receivers' notice of appointment is exhibited to the Kirk Affidavit, marked '**PWK10**'. On 25 May 2010, Mr Fung replaced Mr Longley as Receiver of the charged assets of TOT RE.

Sale Process

Sale of the Bella Vista property

As described in paragraphs 20 - 86 of the Kirk Affidavit, the Receivers have conducted a sale process of the Bella Vista property (**Bella Vista Sale Process**) and have entered into a sale and purchase agreement (**Property Sale Contract**) with

Costa Holdings Investments Pty Ltd (ACN 140 921 053) (Costa). A copy of the Property Sale Contract is exhibited to the Kirk Affidavit, marked 'Confidential Exhibit PWK36'.

- 14 Clause 5.1 of the Special Conditions to the Property Sale Contract provides that settlement is conditional upon, inter alia:
 - (a) the Court directing that the Liquidators of TSL are justified in procuring TSL, in its capacity as RE of the Table Grape Projects, to extinguish all of the rights of Growers (including under the Grower Licences) in respect of the Bella Vista Property and the Water Rights; and
 - (b) the Court making orders determining the rights of all and any persons to all or any part of the net proceeds of the sale under the Property Sale Contract, or ordering that those net proceeds be held on trust until the rights of those persons are determined by a further order of the Court.
- I am informed by the Receivers that the conditions precedent are necessary so that the Bella Vista property may be transferred to Costa at settlement free of any encumbrances relating to the rights of Growers or any Growers' claims.
- 16 The Liquidators and TSL are not parties to the Sale Contract.

Sale of the Water Rights

- As described in paragraphs 91 104 of the Kirk Affidavit, the Receivers have conducted a sale process of the Water Rights (Water Rights Sale Process) and have entered into a sale and purchase agreement with:
 - (a) VicSuper Ecosystem Services Pty Ltd (ABN 42 117 726 164) in relation to the sale of the Victorian Water Rights (**VWR Sale Contract**); and
 - (b) Tandou Ltd (ACN 001 014 562) in relation to the sale of the NSW Water Rights (NSWWR Sale Contract).

M. 76 de M A copy of the VWR Sale Contract and the NSWWR Sale Contract are exhibited to the Kirk Affidavit, marked 'Confidential Exhibit PWK41' and 'Confidential Exhibit PWK42'

- 18 It is a condition precedent to the settlement of the VWR Sale Contract and the NSWWR Sale Contract that the Property Sale Contract settles.
- The Liquidators and TSL are not parties to the VWR Sale Contract and the NSWWR Sale Contract.

Sale Transaction

- We have not conducted a review of the Bella Vista Sale Process or the Water Rights Sale Process (together, the **Sale Process**). The Receivers have confirmed to us that they have complied with their obligations in general, and their obligations under s 420A of the Act.
- 21 We agreed to seek Court approval for the release of Grower rights because it was apparent that the Sale Process would not proceed without it.
- We have negotiated the terms of a deed recording our agreement to obtain Court approval for the release of the Growers' rights with the Receivers. The terms were recorded in a deed entitled the "Bella Vista Grower Rights Deed". Execution of the Bella Vista Grower Rights Deed was completed on 23 December 2010. Now produced and shown to me marked "MAK-1" is a copy of the Bella Vista Grower Rights Deed.

Power to Extinguish Grower Rights

TSL is RE for a number of Managed Investment Schemes (MIS), including MIS for the cultivation of eucalypts (Forestry Schemes), almonds (Almond Schemes), olives (Olive Schemes) and citrus (Citrus Schemes). Since shortly after the commencement of the voluntary administration of TSL and the Timbercorp Group companies we developed a strategy for, and then managed, an orderly realisation or recapitalisation of the Forestry Schemes, Almond Schemes, Olive Schemes, Citrus Schemes, Table Grape Schemes and other schemes. This process has resulted in an informal winding up of those schemes whereby the Court has made orders in respect of the Forestry Schemes and the Almond Schemes that we are justified in procuring TSL to amend the constitutions of each scheme to give TSL the power to

terminate or surrender the growers' licences or sub-leases to land on which the schemes are operated. In relation to the Olive Schemes, we informed the Court on 28 August 2009, that, as we had already obtained directions that we were justified in amending the Forestry and Almond Scheme constitutions, and did not wish to waste judicial time or spend more on legal fees to argue for the same directions, we proposed to make the same amendments to the Olive Scheme constitutions. Representatives of ASIC and the growers were present at the hearing and did not object to that course of action. The amendments to the Citrus Scheme and Table Grape Scheme constitutions were made in the same context. We will only terminate or surrender the growers' licences or sub-leases once the Court has directed we are justified in entering into the sale agreement and the sale agreement has completed. I set out the history of the applications for the Forestry Schemes, Almond Schemes and Olive Schemes in more detail at paragraphs 41-57 in my affidavit sworn 10 November 2009 and filed in Supreme Court proceeding SCI 2009 9998 regarding the sale of olive assets (Olives Affidavit). Now produced and shown to me and marked "MAK-2" is my Olives Affidavit (without exhibits).

- It is apparent from this history that on two occasions we have sought and obtained approval from the Court to amend the scheme constitutions so as to give TSL the power to terminate or surrender the growers' licences or sub-leases to land on which the schemes are operated. As a result, following the making of each of the sets of orders, we believed that similarly amending the constitutions to other projects following similar sale processes would be uncontroversial.
- On 14 December 2009, our solicitors, Arnold Bloch Leibler, wrote to Andrew Tregear of ASIC informing him of our intention to amend the constitutions of the Table Grape Projects (Constitutions). A copy of this letter was also sent to Clarendon Lawyers and Maurice Blackburn who act for Growers and have previously appeared in applications relating to the Timbercorp MIS. Now produced and shown to me and marked "MAK-3" is the letter dated 14 December 2009 to Andrew Tregear and the covering email of the same date.
- On 18 December 2009, Andrew Tregear responded to Arnold Bloch Leibler's correspondence. Now produced and shown to me and marked "MAK-4" is a copy of Mr Tregear's email of 18 December 2009.

- 27 By deeds dated 29 December 2009 and 28 January 2010, we amended the Constitutions to make explicit the RE's power to surrender or terminate the Grower Licences. Now produced and shown to me and marked:
 - (a) "MAK-5" is the 2004 Project constitution (together with earlier deeds of amendment) and the deeds amending the 2004 Project constitution; and
 - (b) **"MAK-6"** is the 2005 Project constitution (together with earlier deeds of amendment) and the deeds amending the 2005 Project constitution.

We will not exercise this power to surrender the Grower Licences until the Sale Contracts are completed to ensure that the Growers receive consideration for the surrender of their rights.

- The amendments to the Constitutions were made in the context of the insolvency of TSL which had no funds to continue to manage the Table Grape Schemes. The amendment was made in anticipation of enabling an informal winding up of the Table Grape Schemes.
- 29 If we exercise the power to surrender the Grower Licences, we will also disclaim the Parent Leases and the Sub Leases on the grounds that those agreements are onerous.

Conclusion

- 30 In summary:
 - (a) the Table Grape Projects the subject of this application are conducted on Bella Vista property which is owned by the TOT RE;
 - (b) the Receivers have been appointed as receivers and managers of the charged assets of TOT RE (which includes the Bella Vista property);
 - (c) the Timbercorp Group is hopelessly insolvent and cannot maintain the table grapes growing on the Bella Vista property;
 - (d) the Receivers have confirmed that they have complied with their obligations pursuant to s 420A of the Act in conducting the sale process;

- (e) the Property Sale Contract, VWR Sale Contract and the NSWWR Sale Contract are the result of the Receivers' test of the market;
- (f) the net proceeds of sale under the Property Sale Contracts, VWR Sale Contract and the NSWWR Sale Contract will be held on trust pending the Court's determination of the entitlements of interested parties, including Growers; and
- (g) it is appropriate to extinguish the Growers' rights to enable the Property Sale Contract, VWR Sale Contract and the NSWWR Sale Contract to complete.
