- (e) send an email to all the members of the First Respondent at their last known email addresses, notifying them of the general nature of the Court documents and that the documents have been posted on that website;

5. Costs reserved;

AND THE COURT DIRECTS THAT:

- 6. The applicants file and serve any affidavit material by 4pm on Monday 18 November 2013;
- 7. The respondents file and serve any affidavit material by 4pm on Wednesday 27 November 2013;
- 8. The parties serve any objections in relation to the affidavit evidence by 4pm on Friday 29 November 2013;
- 9. The parties file and serve any further affidavit material by 4pm on Wednesday 4 December 2013;
- 10. The applicants file and serve their written submissions by 4pm on Monday 3 February 2014;
- 11. The respondents file and serve their written submissions by 4pm on Thursday 6 February 2014; and
- 12. The Application be listed for hearing for three days on the Civil List, from 10 to 12 February 2014.
