## THE COURT ORDERS THAT:

- 1. The applicants post the second affidavit of Simon Vertullo sworn 13 December 2013 in PDF form on the website "<a href="http://www.kordamentha.com/creditor-information/australia/109",">http://www.kordamentha.com/creditor-information/australia/109",</a> by 4pm on 17 December 2013.
- 2. The applicants post:
