- I, MARK ANTHONY KORDA of Level 24, 333 Collins Street, Melbourne, in the state of Victoria, Chartered Accountant, MAKE OATH AND SAY that:
 - I am, with Leanne Kylie Chesser, the liquidator of the First Plaintiff, Timbercorp Securities Limited (in liquidation) (**TSL**).



- Except where I otherwise indicate, I make this affidavit from my own knowledge. Where I depose to matters from information or belief, I believe those matters to be true. I am authorised by Ms Chesser to make this affidavit on her behalf. References in this affidavit to "we", "us", "our" or "ourselves" are references to Ms Chesser and me.
- I refer to my affidavit of sworn 4 December 2009 and filed in this proceeding (First Affidavit). I adopt the same abbreviations and defined terms as I used in my First Affidavit.
- Exhibited as MAK-5 to my First Affidavit was the Spreadsheet showing the apportionment of Net Sale Proceeds between Forestry Growers.
- During the hearing of this matter on 9 December 2009 (**Hearing**), our counsel tendered as exhibit 1 an updated version of the Spreadsheet (**9 December Spreadsheet**).
- At the luncheon adjournment of the Hearing we identified an error in the 9 December Spreadsheet. The 9 December Spreadsheet showed only one line for the 2002 Forestry Scheme. However the 2002 Forestry Scheme has two Projects, the "2002 Eucalypts Early Project" and the "2002 Eucalypts Post June Project". The Disclosure Document for the 2002 Forestry Scheme says that pooling of proceeds from Wood is to occur across the Projects, not the Scheme.
- I have therefore instructed my employees at KordaMentha to amend the 9 December Spreadsheet to divide the line for the 2002 Forestry Scheme into two lines, one for each Project. Now produced and shown to me marked MAK-14 is the updated Spreadsheet, amending the 9 December Spreadsheet (Amended Spreadsheet). The change is shown in yellow highlight. There are no other changes between the 9 December Spreadsheet and the Amended Spreadsheet.



If the directions sought are made, we intend to distribute the Net Sale Proceeds to the Forestry Growers in accordance with the Amended Spreadsheet, unless we identify an error in our assumptions. In which case we will not make the distributions without bringing this matter back to court.
