- I am an employee of the firm Macpherson + Kelley Lawyers (M+K Lawyers), the solicitors for the Second and Third Defendants, being the persons appointed as representatives of all of the growers in the Timbercorp project of which they are a member (together the Representative Growers). I have carriage of this matter on behalf of the Representative Growers under the supervision of my principal, Michael Fernon, and I am authorised to make this affidavit on their behalf.

read the 11 April Communication Spreadsheet and note that since 23 March 2014, there have been four Return to Sender notifications sent to TSL and no other grower communications to TSL according to the 11 April Communication Spreadsheet. Now produced and shown to me marked **confidential exhibit YCH-7**) is a true copy of the email from Ms Moodie of TSL to me attaching the 11 April Communication Spreadsheet.

- Confidential exhibit **YCH-7** is contained in a sealed envelope and the Representative Growers will make an application for an order that they be kept confidential as the 11 April Communication Spreadsheet contains growers' personal information.
- I have read the Communication Spreadsheets and note that since 23 March 2014, a total of 8 growers made comments or asked questions in relation to the Deed of Compromise. Among them:
 - (a) five growers were contacted by TSL by telephone after TSL received Return to Sender notifications in relation to their postal addresses. TSL updated the details of these growers and sent them copies of the First Notice to Participant Growers at their nominated email or postal address;
 - (b) five growers returned their Bank Account Nomination Form and/or their Direction to Pay to TSL;
 - (c) no growers lodged objections or made Escalated Queries or Comments; and
 - (d) there were also three Return to Sender notifications sent to TSL.
